The Shawsheen Valley School of Practical Nursing is designed to provide eligibility for the graduate to take the NCLEX-PN (National Council Licensure Examination for Practical Nurses) examination upon graduation.

The program is offered in a weekend (7-8 AM-3-4 PM) and evening (5-11 PM) format following the high school's forty (40) week calendar. The program starts the last Monday of August and concludes the end of June.

This course provides the theoretical framework, skills laboratory and clinical practices that enable the graduate nurse to work within the scope of the practical nurse in Massachusetts.
